

16th District Sprig Convention

El Paso, Texas April 1-3, 2022

1. 16th District commander David Crozier called the meeting to order at 9:15 A.M. April 3, 2022 at El Paso, Texas.
2. Opening ceremonies were conducted in accordance with the Officer's Guide.
3. Adjutant Folmar read the Convention Call and conducted Roll Call. 9 posts were present and 8 were absent.
 - a. The following posts were present: Post 19 (Midland), Post 36 (El Paso), Post 58 (El Paso), Post 74 (El Paso), Post 79 (Alpine), Post 233 (Pecos), Post 339 (Kermit), Post 430 (Odessa) and Post 832 (El Paso).
 - b. The following posts were absent: Post 119 (Midland), Post 122 (Anthony), Post 160 (Sanderson), Post 176 (Presidio), Post 234 (FT Stockton), Post 253 (Big Lake), Post 407 (El Paso), post 5989 (horizon City) and Post 653 (Terlingua)
4. A motion was made to suspend the reading of the previous convention minutes. The motion was seconded and passed.
5. Commander Crozier called for the following reports:
 - a. **Rules and Credentials:** Committee Chairperson Ruber Banks reported the committee met April 2, at 9 A.M. at El Paso Post 58. There were 9 posts who turn in credentials (see roll call). Motion was made to accept the report as read. The motion was seconded and passed.
 - b. **Convention City:** Committee Chairperson Rusty Herman reported That the committee met April 2, at 9 A.M. at El Paso Post 58. The following posts will host the next 5 conventions: Fall 2022 Alpine Post 79, Spring 2023 Midland 19, Fall 2023 El Paso Post 58, Spring 2024 Alpine 79 and Fall 2024 Odessa 430. A motion was made to accept the report. It was seconded and passed.
 - c. **Finance Report:** Committee Chairperson Richard Britton reported the committee met April 2, at 9 A.M. at El Paso post 58. The report covers 16 October thru march 2022. The beginning balance was **\$9,892.58**. There was on deposit from the fall convention **\$250.00**. There was one expense for this report. Travel expense for the District Oratorical contest

winner, to Odessa, TX for 4th Division contest (\$95.00). The ending balance is \$10,047.58. A motion was made and seconded and it passed.

d. **Resolutions:** Committee Chairperson Tony Morgan reported that the committee met at April 2, at 9 A.M. at El Paso post 58. There were 3 resolutions for information only and one to thank Post 58 for hosting the convention. Glen Scott asked to have the resolutions for Roger Folmar and David Crozier be set aside. After discussion both candidates were endorsed by the 16th District. A motion was made to accept the report. It was seconded and passed.
